This sheet provides information about the research project and the researchers and invites you to participate in this study.

## What does the research involve?

The aim of this research is to investigate how placement students, host supervisors as part of host institutions, education providers represented by their placement coordinators, and accreditation bodies see the value of placements. The scope of placements covered in this study includes placements in Australia for GLAMR students, both those of undergraduate and postgraduate levels within the period of 2020 to 2023.

The research is a case study of qualitative methods. Four groups of participants, including placement students, host supervisors, education provider staff members in charge of placements, and accreditation body key personnel will be recruited via email from June 2022 to the end of 2023. To protect participant confidentiality, the researcher will take every care to remove any identifying material from the responses provided and each participant across all four groups will be allocated a pseudonym.

Data collection will be carried out from mid-2022 to mid-2024 through individual semistructured interviews, both online and face-to-face depending on situations. Each interview is expected to last for approximately 30-45 minutes. interviews will be audio or video recorded for transcription purposes.

## Why were you chosen for this research?

You have been chosen for this study because we are targeting participants who are placement students, host supervisors, education provider staff members in charge of placements, and accreditation body key personnel within the period of 2020 to 2023.

## Consenting to participate in the project and withdrawing from the research

Your participation in this study is entirely voluntary. Prior to your individual online interview, the researcher will read out the points listed in the provided consent form and will need to gain your verbal consent/agreement. However, even after you have provided your informed consent, you may still choose to withdraw from further participation. You may withdraw from

the research at any time before the end of data collection period (by 03/06/2024). Your choice to withdraw will not affect your position or relationship with the university, now or in the future.

In this event any data identified as yours, will be removed and will not be used by the researcher. In addition, withdrawal of consent may involve participants choosing to not respond to certain questions or ask for their answers not to be recorded or removed. Participants will be offered the opportunity to review their interview transcript.

## Possible benefits and risks to participants

Potential key benefits include the opportunity to learn other participants' (unidentifiable) experiences that are gained from the programs. There are no anticipated risks associated with participation in the study (study beyond those encountered during everyday life), as the interview questions are not in any way sensitive in nature.

## Confidentiality

Being a participant in this study is voluntary and you are under no obligation to take part. The study will be submitted for publication, but individual participants will not be identifiable. Pseudonyms for participants and the people they refer to (excluding the researchers) are to be used in both the thesis and any publications. All participant information will be treated with strict confidentiality and no information which could lead to identification of any individual will be released, unless required by law. While roles will to some extent be disclosed in general terms (e.g. "placement student", "host supervisor", "accrediting body staff", "placement coordinator"), organisations and institutions will not be disclosed in the reporting of results. The publication will be in the form of a conference presentation and an article, where aggregate results of this research will be included.

## Storage of data

Participants are required to read the participant information and provide verbal consent that will be recorded on the same platform as the online individual interviews and will be the beginning (right prior to) part of recordings of the interviews. Consent forms, transcripts, data coding materials, and recordings are to be stored on the secure UniSA computer server for 5 years following final publication. Only the student researcher and her supervisor will have access to this stored data. After this period, all records will be destroyed.
